1 Year Limited Warranty

- Drum Shells
- WTS Tuning System Components
- Bass drum hoops
- All strainer parts, and all nuts and bolts

This Warranty Does Not Cover

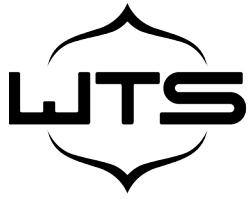
- Cable, springs, heads, and wire snares.
- Normal wear and tear.
- Improper maintenance or repair, including the installation of non-WTS parts or components.
- Instruments sold as second hand.
- Instruments that have been altered, modified, or have been damaged through misuse, negligence, and improper operation (including, but not limited to, over-tensioning).
- Instruments whose trademark, name, or identification number has been changed or removed.
- Instruments subjected to abnormal strain, neglect, abuse, modification or exposure to extreme temperatures or humidity.
- Powder Coat and Lacquer Finishes – Powder coated and lacquered finishes are highly sensitive to cosmetic damage that can occur during normal handling and use. Therefore, no warranty of any kind, including any implied warranty of merchantability or fitness for a particular purpose is provided against cosmetic defects or appearance damage to these finishes.

Owner's Responsibility

Upon discovery of an alleged defect, notify your authorized Welch Tuning Systems dealer with a detailed explanation and pictures. Upon authorization from your authorized Welch Tuning Systems dealer, ship your product to Welch Tuning Systems warehouse located at 260 Lore Lake Rd. Kalispell, MT. Freight and insurance for returned product will be the responsibility of the owner.

General Conditions of Warranty

Welch Tuning Systems will return the product to the owner at the expense of Welch Tuning Systems, provided the defect is judged to be covered by this limited warranty. Products not covered by this
